Rarely available in one of Surrey's most sought-after industrial submarkets, this property offers a strong combination of functionality, exposure, and long-term flexibility.

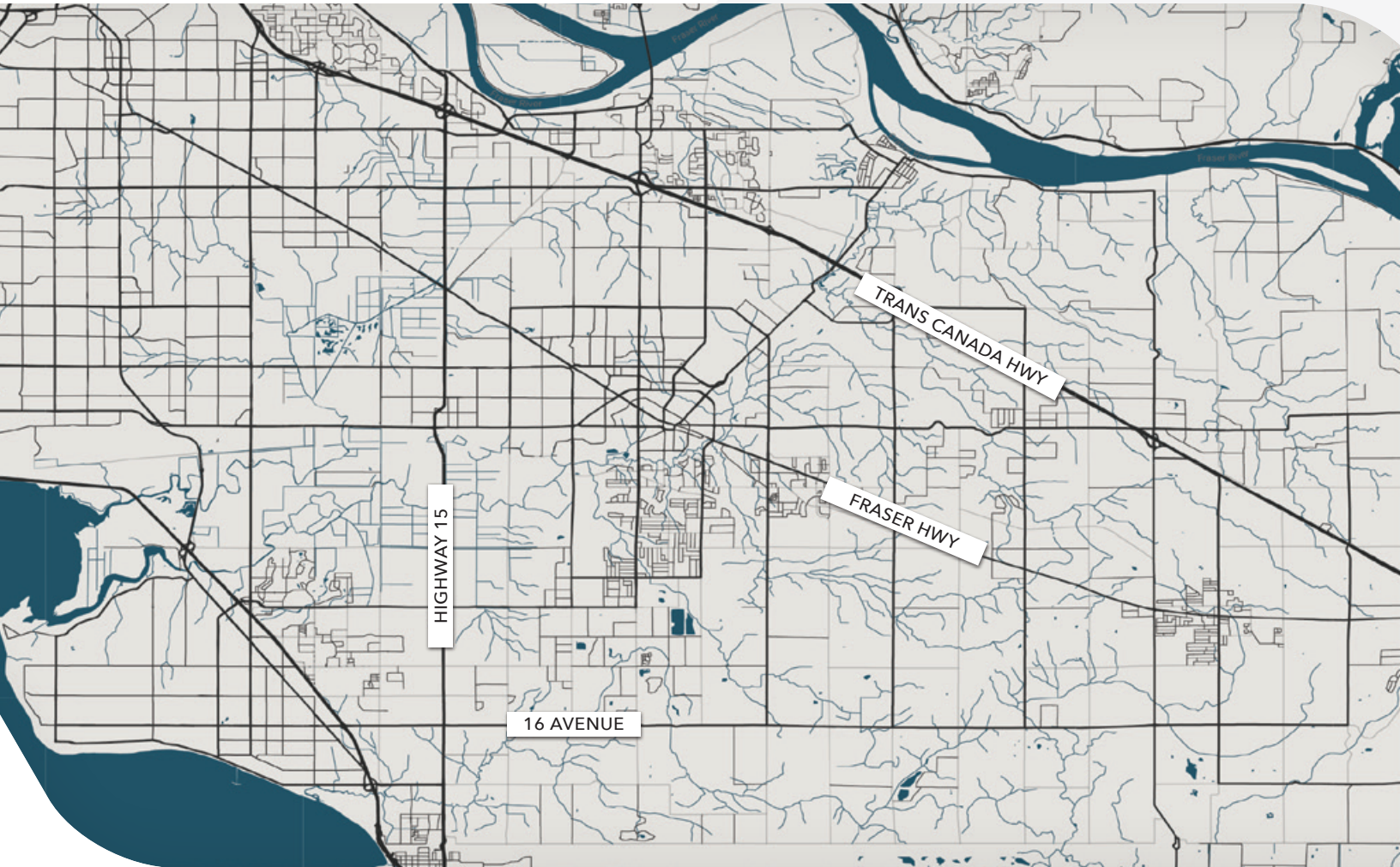
